Hunter Urban division chair Dr Arn Sprogis fears that unless there's some serious action on the reform front, the top-down scenario will prevail.

# Hospital says surgeon's stress levels posed a risk

Fears that personal stress and poor relations with colleagues could lead to patients being harmed were cited yesterday among reasons the Royal Children's Hospital had ordered prominent surgeon Paddy Dewan to take extended leave.

Kidney and bladder procedures on 10 children were cancelled yesterday as the hospital hit out at Professor Dewan, who last week questioned its ability to deal with medical errors.

Women's and children's health chief executive, Associate Professor Kathy Alexander, said the hospital regretted the anguish and anxiety of parents and children whose operations were cancelled or are due to be rescheduled.

"I currently believe that the stress levels both of the individual concerned and also of the team within the department of surgery are now so high that a child undergoing surgery at the moment within that department may be under serious risk," Professor Alexander said.

Professor Dewan's enforced leave earlier this week follows months of acrimony at the hospital. He was asked to resign in April but refused, prompting a board-level inquiry into allegations against him by colleagues. Professor Alexander said complaints against the surgeon by his colleagues went back five years.

"Paddy Dewan is a very able, very energetic, aggressive, opinionated and passionate individual," he said. "Some individuals who have those sort of characteristics do have difficulties maintaining comfortable relationships within a team."

Professor Alexander has recommended to the board that Professor Dewan's contract be terminated. A decision will be made within a month. "The whole department of surgery has indicated to me that they can't work under these circumstances any more," she said.

She said Professor Dewan's 10 patients due for surgery yesterday "may be at significant risk if the procedures were allowed to go on".

"The situation at the moment is so stressful that there is a

potential risk and I am avoiding that risk. I am not saying he is an unsafe surgeon," she said.

Mathew Dean, 12, was due for surgery on a kidney stone yesterday, his 65th operation at the hospital following his premature birth. "I couldn't believe I was in an emergency situation and had nowhere to turn," said his mother, Sue O'Connell from Geelong. "I don't want to go to another hospital. I don't want to go to another surgeon."

After meeting Professor Alexander and doctors at the hospital, Mathew went to the Sunshine Hospital, where Professor Dewan late yesterday performed the operation.

Professor Dewan said suspending him was not in the best interests of patients. "I deeply regret that interpersonal conflict has reached the point of further adversely affecting patient care," he said. "I would never refuse to work with someone just because I didn't like them."

#### Dewan back in theatre

SUSPENDED Royal Children's Hospital surgeon Paddy Dewan has turned to the Sunshine Hospital to operate on one of his patients.

The outspoken surgeon, labelled "too stressed" to operate at the RCH, performed emergency surgery on 12-year-old Geelong boy Matthew Dean on Friday night.

A plastic drainage tube

attached to Matthew's kidney became blocked, needing to be urgently removed.

Matthew's mother, Sue O'Connell, said yesterday she and Matthew had been through a tough ordeal, with Professor Dewan's suspension making a difficult time even worse.

Ms O'Connell said going shead without Prof. Dewan was not an option. "He's an incredible surgeon and an incredible man and he has successfully operated on Matthew," she said.

Ms O'Connell said being forced to go to another hospital was tough on Matthew, who had bathled a range of medical conditions since his premature birth.

She said Prof. Dewan was being treated badly by the RCH.

## MPs visit the coalface for the real GP story

A MORE tolerant and fairer community attitude and wellplanned government policies will go a long way to solving some of the problems that are plaguing general practice, two South Australian-based federal politicians believe.

Affairs minister Foreign Alexander Downer and Liberal Member for Grey Barry Wakelin said they were stronger advocates for the medical profession after spending some time in the surgeries of South Australian GPs last week as part of the AMA's Family Doctor Week.

Mr Wakelin said he empathised with doctors for the demands made upon them and the lack of understanding shown

"We expect a lot of our doctors and I think the community needs to be a bit more tolerant. I am certainly going to try to achieve a society that gives a fairer approach for doctors to operate in," he said, after spend-

ing an hour with Port Augusta GP De Randya Bhola.

(Mr Downer, who visited Dr Lindy Poole in the Adelaide Hills, said GPs faced more problems than most small businesses, including workforce shortages practice was welcoming, it remained to be seen if this would be translated into policy changes.

However, she added that the 90-minute meeting was very positive and felt she had enlightened Mr Downer about a number

and indemnity pressures that needed comprehensive solutions.

"A lot of GPs now work parttime rather than full-time and the supply of GPs into the marketplace, which is controlled, hasn't taken that into account sufficiently," Mr Downer said.

"I also know that the real ... carnings of GPs have declined a for their role by the community. Not over the past few years and these border health issues ... are all very difficult problems to solve and they can't be solved by just throwing money at them."

Dr Poole said while the politician's attentiveness and genuine concern for the future of general of topics, including workforce shortages and the increasing burden of red tape.

"It's one thing to be talking and another thing to see some results, but it was great to have the luxury of having an ear all to yourself," she said.

Meanwhile, Dr Bhola has received an invitation from Mr Wakelin to meet on a regular basis to discuss the many issues plaguing general practice.

"He was very positive, but as to how much he will break away from party lines and take up some of these issues, I don't know," Dr Bhola said.
