Dear Committee, I thank you for the  
opportunity to add my experiences.

I am presenting this submission, not  
from the probable usual starting point, but  
from the outcome of state contrived, as  
a direct result of serious inadequacies or  
worse, of the statutory bodies etc. to  
"Protect the Public".

My submission is directly from personal  
experience, researched records and informa-  
tion which cross links with the sexual abuse

of children and others, whether the actions took place within an institution and elsewhere.

I aim to give the Inquiry another view of how common the illegal activities are and yet NEVER recognized or addressed publically by any acceptable means or standards.

You do not have to be a member of Mensa to work out how this destroys not only the abused individual but the entirety of society.

The cost is enormous. No politician or law/legal agency dare add up the cost. Physical, emotional, financial - individual and State/Commonwealth, then often ending with nothing more than extreme anger and disgust.

My 'saga' is one of continual illegal activities perpetrated against me and mine, abuse, slander, property loss and/or damage.

There are many times when I think my situation would be much improved if I mimicked the behaviour of the perpetrators

eg. Legal and Medical Boards,  
I have the strong feeling the authorities  
are simply waiting for me to go to my grave,  
while meantime - abuse me verbally and  
showing their disdain for persons who  
simply wish the truth to be addressed, with  
the ability to live in safety and dignity.

Much of the abuse which took place  
late 1970's - 1980's was both physical and  
psychological torture.

The very striking message is clearly  
given to Australian citizens is:—  
if you are tortured in Australia —  
tough!

There are well recognized support groups  
for immigrants who have been tortured  
before living in Australia.

There is much published about torture  
in those countries over there.

But tough! if you are tortured by  
the medical profession and cohorts in  
Australia.

So far, all of the above contributes to the destruction of the individual, family, societal "Mental Health."

Why is Australia hell bent on destroying the good health of citizens.

South Australia insists on keeping me in a metaphorical bound and gagged position.

I submit a legitimate complaint against a so called medical practitioner. From that time on - No address of complaint, big time effect on obtaining acceptable health care, including general health, dental, and optical, while at the same time, waste of my finances - thus ending in the situation of the inability to keep myself healthy - even basic.

This is common behaviour by health providers, which negates any effort to care for one self any more - energy and financial.

Conducive to strong "mental health"?

Many fraudulent claims - Health Insurance Commission and private health insurance.

This is another area in question.

If the original fraud and substandard health provision is not addressed by the State bodies - you cannot address the health insurance fraud.

HIC - patterns can be picked up . . .

- if not obvious pattern - but with the assistance of the griever - the fraudulent claims are obvious.

therefore not only person but State and Commonwealth lose.

This can and often does extend to Work Cover Claims - and so on.

HIC - Medical Practitioners' names unknown to myself, have been used to claim.

One General Practitioner found it difficult to comprehend when I recently approached him via phone -

how and why - his name was used by another medical - Hughe Meyler - the latter never using his own name.

One name is not known to the Medical Board. Was he a 'doctor'? was he a person at all?

This is only the beginning.

Have I been offered any assistance  
from any authorities or any what ever?  
NO.

I have been researching, the torture,  
Abuse, ~~at~~ covert surgical procedures,  
covert use of hospital facilities (a  
well known private hospital in the Adelaide  
City Square.)

I have attempted to research all  
medicos. involved. This has been much  
more difficult. In fact - starting with  
nothing, the whole has been and is,  
very difficult.

Untruths - verbally and written, to  
medical and other health care practitioners,  
generate further substandard 'health care'  
involving serious dental negligence and  
the refusal to rectify.

The untimely death of my mother -  
was connected with the illegal, covert  
use of hospital facilities.

The South Aus. Inquiry into our Medical  
Board is continuing.

The area I have been attempting to address is not - Your Mental Health Issue.

It is serious abuse and criminal assault issue resulting in permanent bodily damage as a result of physical and psychological torture with subsequent post traumatic stress - a normal reaction to an abnormal event/s.

The numerous flashbacks are obscene. I do have a Medico-Legal (not from S.A.) but have been unable to obtain intelligent honest legals - who are not married to the medicals - in S.A.

Many areas are made difficult as South Australia is described as incestuous, however the 'small' also enables us to compare research with more persons.

'Mental Health'? I do not think this is allowed in S.A.

Accountability - where?
