Dear Sir Madam,

I am a little bit lae with my submission yet what i have to say may be of some interest.

I was placed into Dandenong Hospital back in 1992 and treated for Bi-Polar. From the time i was admitted i was administered with numerous medications and not aloud to leave the Hospital.

I was then told some days later i had Bi-Polar and was a very sick man.

I and my lady friend were not convinced of this and continued to have the Doctors explain.

This was of no use and had came about due to the military stories i was telling staff and the traumatic events i had enjured.

Doctors were not convinced any of these military events occured and did not bother to check on any of them.

I had been suffering from PTSD. The continued treatment for Bi-Polar went on for many years, and i was always complaining of the Diagnoses and was refused and reassements.

I then went to the AAT and later Federal Court to challange the diagnoses. Even the courts were not convinced yet decided to maintain i suffered from Bi-Polar and was a very sick and delusional man.

I could not find any answers nor doctors that were going to give me a fair go untill now.

I recently was placed on an I.C.O. Intensive corrections order and to see Doctors for the 12 months duration.

The Doctor i am to see, has known me for several years and has determained i do not and have never suffered from Bi-Polar ever, and in fact it was PTSD all the time and not ever was i treated for this problem.

I choose to remove my self from medications all to gether some 5 years ago. Not only has my life inproved but my educational skills and abilities also. Many Certificates in Building and Construction as well as Associate Diploma, Diploma, Low Rise Builder and many other Qualifications. Some 4-6 years study in only 9 1/2 months. One of only 3-4 to pass and the only one of two to do so from first attempt.

I was placed on bail for almost 2 years as well as studying and having to look after my mother whom died during this period of time. All of this happening during the same year and still making the Goals i set for myself.

I had also reprsented myself in a number of Commom Law cases and the odd civil mater, winning all of them and running them all at the same time.

Without going on with it all, one can plainly see these are not the activities of someone suffering from BP and the extreme stresses of this life i live and my recent achiements during the harshes of human suffering, i still was composed and provided excellent results for a man not taking meds, seeing doctors and his world falling down around him but still overcomes difficulties most would not or could not do on their own, as i was on my own the entire time.

I am going to get my justice whether or not you want to use this statement or not.

I spent the best years of my life being told i have something i do not and being treated with such contempt and having to put up with Delusional Doctors saying i have BP and The Department of Defence trying to hold back their joy as i was never going to win my case.

This Government and the Medical Faturnity of this country distroyed my life and the life of the Children i will never have. Losing my wife and not being able to inform my mother she did not raise a family of nutters.

I will never give up trying to clear my families name and the inhuman methods used by this countries Doctors to save their own arses because they got it wrong and are to GUTTLESS to admit it.

Did i mention i was treated with E.C.T for now an illness siad i dont have. Did i mention recently i was diagnosed with Schizophrenia by Redlands Hospital here in Qld on the 13th May and setenced for an offence based on the ruling of that Hospital, and found guilty and told i have to go and see doctors again, but this time for an illness i do not have. Why do i say this, because i have the letter from that Hospital saying they made a terrible mistake and i have never suffered from Schizophrenia ever.

12MTHS JAIL and told i have to see a doctor during the entire time. I can redress this order, but the compensation will look a little better if i was to serve the entire time.

I am going to register my complaints via the Media and when you are finished with your Inquiry, i am going to sue each and everone of those incompetant morrons whom call themselves Doctors. One by one.

I have a data base of over 4337 patients suffering from BP and other illnesses. Many believe i have found some cure for this debilitating illness but i have not. Yet why not use them to fight the Department with, ummmmmm how you may ask, anyway i want to.

How the Government and doctors think this is all going to go away never seems to amaze me. You are all a mob of selfish, heartless Fucking bastards, and for the next 20-30 years of my miserable life i am going to never let up.

How many poor souls took their lives due to this hospitals doctors misdiagnosing patients? How many families lost a love one because Doctors decided not to inform them that the Diagnoses may have been incorrect?

How many patients with not the illness diagnosed spend their time in a world of hurt and pain created by these incompetant dickheads that call themselves Doctors?

TO MANY.....

Being called a Psychiatrist must give them a sence of power and control over their patients and if the patient suggests they have it wrong, then just give them another needle to shut them up hey.
