Inquiry into Ministerial Discretion in Migration Matters

I refer to your letter dated 5 August 2003 requesting statistical information in relation to migration matters in the Administrative Appeals Tribunal.

Please find enclosed a table listing the number and type of migration matters that have come before the Tribunal since its establishment. Also enclosed is a table listing the number of those matters that have been affirmed or remitted. Please note, however, that although the Tribunal was established in 1976, no migration matters actually came before the Tribunal until 1984.

Unfortunately, the Tribunal does not keep information on the number or file numbers of those cases where the Tribunal affirmed a decision of the Department of Immigration but recommended to the Minister that he may wish to exercise his discretion in the matter. My understanding is, however, that such cases would represent a very small proportion of migration matters.

I trust that this information is of assistance.
