Please find enclosed our Submission requesting that there be no diversion of waters of the Clarence River.

Apart from our environmental concerns, the river flow reductions would cause increased silting and decreased navigational depth restrictions which would have devastating operational and commercial ramifications for the Shipping operations through the Port of Yamba. This could cause the loss of many hundreds of permanent and casual jobs both directly and indirectly. A current Shipping Schedule is enclosed to show the Ports of call from the Clarence River.

We have been involved in Shipping out of the Clarence River since 1984 and have owned and operated many ships from this Port during this time.

The Port of Yamba at the mouth of the Clarence River is ideal for small ships

operating to the South Pacific Islands and provides crucial lifelines to the remote Island Communities of Lord Howe Island and Norfolk Island who are service by only one supply ship to each Island which are both based in the Clarence River and the Port of Yamba.

Koppers Logs in Grafton are a big exporter of their product of Poles and vessels used for this trade are already seriously draft restricted.

I trust that there will be no reduction of river flow from the possibility of water diversion that would threaten the many hundreds of jobs generated through Port activities on the Clarence river.

"Its probably twice the size of anything we've worked on in the past" slipway director Ross Roberts said.

Mr. Roberts said more than a million dollars had been spent on the slipway over the past year, enabling boats up to 80 metres in length and 3,500 tonnes in weight to be serviced at the slipway.

"It's a real milestone and further consolidates and secures the future of our workers." Mr Roberts said. "We have bookings up till the end of the year."

The slipway currently employs 50 people.

Previously the ship was slipped in New Zealand. "The beauty is that around \$500,000 will be injected into the Clarence Valley economy." Mr. Roberts said.

The Norfolk Guardian is a regular visitor to the Clarence, providing a regular service to Norfolk Island from the ports of Yamba and Auckland, New Zealand, It regularly transports hardwood from Australia to New Zealand, with a return cargo of softwood.

The ice-class ship is 76 metres long, with a beam of 12 metres and draft of five metres. Inspectors from Lloyds of London are monitoring progress of the ships' overhaul.

Guardian of the River

The cargo ship Norfolk Guardian has become the largest vessel slipped in the Clarence River in New South Wales, providing an impressive sight that can be viewed for miles around.

Harwood Slipway spent more than \$1m on an extensive upgrade of the slipway, enabling it to take vessels up to 80 metres in length and 3,500 tonnes.

The 2,400 dwt Norfolk Guardian provides a regular service to Norfolk Island from Yamba and Auckland, carrying all domestic and industrial supplies to the island.

The ship has been purpose built to enable discharge of cargo offshore into small boats, as the island has no port facilities.

The ship also carries hardwood from Australia to New Zealand, with return cargo of pine to Australia.

"During the life of this Assembly, we plan to offer a range of ways for members of the public to raise issues or ask questions of Government and Assembly members", Mr Nobbs said. "This week has seen the first full sitting of the 12th Assembly, so we will be happy to elaborate on any matter raised there, or indeed on any issue relating to the wellbeing, economy and good governance of Norfolk Island".

Mr Nobbs said that at least three Ministers will be in attendance at Rawson Hall from 1.00 p.m. to 3.00 p.m. this Saturday, 21st April. Representatives of the Tourism Board will also be present to discuss any matter concerning tourism. Ship out of water

Harwood Slipway Engineering is currently home to the largest ship ever to be slipped on the Clarence River.

Standing about six stories high, the dry-docked MV Norfolk Guardian can be seen from miles around. The ship is undergoing a full survey and refit, which includes structural steel replacements, machinery and engineering modifications, abrasive blasting and painting and ultrasonic thickness testing of steel structures.
