This submission concerns dishonest, corrupt, fraudulent lawyers in Tasmania, the cover ups, fob offs re complaints against them to the Law Society of Tasmania and the activities of Piggott Wood and Baker. I say Piggott Wood and Baker should be prosecuted for their criminal activities.

When the Official Reciever did nothing about my claim I again complained to the Law Society.

## I RECIEVED NO REPLY TO THIS LETTER OF COMPLAINT

The Whitford matter which is referred to in the letter of complaint was dismissed in the Federal Court by Mr Peter Wood of Piggott Wood and Baker knowingly and deliberately misleading the Court. A pr. of of debt was admitted in bankruptcy for Whitford of about \$780, which proof had been rejected in a previous bankruptcy. When I challenged the admission it was immediately rejected and then Mr Peter Wood told the Court the debt was payable from the surplus of the previous bankruptcy. But the previous bankruptcy was annulled "All debts paid in full and surplus returned to bankrupt". So there was no surplus and provisions in the Bankruptcy Act including 5 153(5) and 154(1)(a) debarring previously rejected proofs of debt being admitted again.

The Federal Court application re Piggott Wood and Baker has'nt yet been filed because knocking North Forest Products off my fraudulently sold wholly protected money land has greater priority as well as hammering Mr Roger Baker's client, Phillip John Griggs, who used the interim restraint order to remove his property from the bankrupt estate.

I have a meeting with Rio Tinto, who own North Forest Products Ltd and have agreed to sell it to Gunns Ltd, at 11 am tomorrow in Hobart.

## Piggott Wood and Baker & the Estate E A B Wright

Trustees Estate E A B Wright (John Turner and Bruce Crawford - partners Piggott Wood and Baker)

Solicitor acting - Grant Kench - partner Piggott Wood and Baker

Lessee - James G Turner

Lease rentals all paid with personal injury compensation money - wholly protected property in bankruptcy

When they tried to illegally evict me - Audrey Mills acting - partner Piggott Wood and Baker (at the same time she was defrauding me of the \$155.72)

James G Turner bankrupt 15/6/87 - Grant Kench, partner Piggott Wood and Baker acting for Official Reciever

I gave Audrey Mills a bath over the illegal eviction (after the event where PWB combined with Roberts Ltd to illegally sell all my livestock and cause the bankruptcy) and PWB were left with a huge bill for legal costs of about \$9,000 and I was give leave to defend. Once I began to defend PWB did nothing to advance the action, but instead filed a proof of debt in my bankruptcy claiming all their legal costs

Proof of debt filed by Peter Wood, PWD, where Grant Kench, PWB, who had carriage of the matter, was representing the Official Reciever

Wright proof of debt wrongfully admitted for about \$4,000 including PWB legal costs where the last Supreme Court proceeding says "Defendant (J G Turner) leave to defend and all costs to date reserved".

James G Turner bankrupt again

Wrongly admitted Wright claim in statement of affairs

Grant Kench, PWD, again acting for Official Reciever, Audrey Mills and Peter Wood appearing in Court

The very first proof of debt filed in first bankruptcy was Stockwell P/L for cattle bought off them which Roberts Ltd

and Piggott Wood and Baker unlawfully sold (The Federal Court has decided/ruled that) and surrender of Official Reciever) are two unregistered mortgages (for the same debt) and two titles to my land.

Stockwell is now an ordinary creditor demanding payment

Stockwell debt not admitted or paid, bankruptcy discharged and annulled

Stockwell debt expunged, dead and buried, unregistered mortgages defunct, cactus

Kench and Andrew Douglas put the defunct mortgages on my wholly protected in bankruptcy land

Wholly protected money land sold using a void Federal Court order (obtained by Peter Wood, void because S 58(2) of Bank-ruptcy Act not complied with) to North Forest Products Ltd and the fraudulent, defunct mortgage paid out.

The only proper recourse Stockwell P/L had was to sue the Official Reciever in negligence.
